1911-00 Those Present

Warp Mill Staithes -Migratory fish access - Environment Agency aware

Badger Hounds bollards - Clerk has met with NYCC Highways and awaiting a revised cost.

Police Cover - further emails - possibility of meeting with PFCC/Police - Cllrs reported on further incidents within the parish when Police response was unacceptable.

New village signs/Wildflower verges - Clerk reported that she had secured funding from NYMNPA for both projects, so hopefully very little expenditure from Council funds.

Dog Pooh Signs - given to Cllr Longster for display in Staithes

Staithes Bus Shelter - Clerk had met with NYCC Highways who disclaim any responsibility for area behind and have advised we ask SBC for ideas to improve it. Cllr Fowler had suggestion of waterproof product that could be painted on rear wall. Clerk to investigate.

Phone Boxes - SBC are trying to keep our phone boxes as we have a poor signal locally.

1911-10 Hinderwell War Memorial Clock
