1912-12 HPC Budget 2020/2021

Cllrs were given copies of the proposed budget. Vote taken to accept. Unanimous

Staithes beach needs cleaning following sewage leak on 19th October, Cllr Watson hoping that Yorkshire Water will pay for clean up.

Coastguard Station, H'well. Cllr Schofield asked for gritting by NYCC - Clerk to contact NYCC.

Coronation Avenue - residents are to ask Beyond Housing to install more car parking - supported.

Staithes Harbour side - unsafe railings between bridge and lifeboat shed - Clerk to contact Loftus TC.
Road Sweeper- has been in parish - comments on greatly improved service we got from Wilf Noble's staff and vehicle.

Grass in roadside kerbs - Clerk to ask NYCC Highways to send "Weed Ripper" to parish.
