2020:01-00 Those Present

2020:01-01 Apologies

Badger Hounds bollards - Clerk awaiting revised cost from NYCC Highways.

Staithe Bus Shelter - Clerk to seek tenders from local builders as to possible repairs to back wall of West bus stop. Cllr Bailey reported on state of the roof and blocked drainage system, Cllr Fowler to investigate before tenders are sent out.

Coronation Av speeding vehicles: Oakridge School has made our concerns known to parents and Police have contacted the driver of the vehicle that had been witnessed speeding.

Runswick Lane, H'well: street lights removed summer 2016 to be replaced very soon.

Missing headstone – believed missing before historic stability checking (Topple Testing).
