

# **Minutes of a meeting of Hinderwell Parish Council**

## **5th March 2020, 7pm at St Hilda's Old School, Hinderwell**

### **2020:03-00 Those Present**

Cllr A Jackson Chair; Cllrs: C Jackson, Buck, Hickman, Fowler, Rogers, Longster, Wilson

### **2020:03-01 Apologies**

Cllr Watson sent apologies, proposed to accept Cllr C Jackson, seconded Cllr Fowler.

### **2020:03-02 Declarations of interest**

None.

### **202:03-03 Minutes of Previous Meeting**

Minutes for February meeting accepted as a true record, proposed Cllr Fowler seconded Cllr Hickman.

### **2020:03-04 Matters Arising**

Badger Hounds bollards - Clerk reported that revised cost was still £1,000 for two bollards which is costly when looking at 6 bollards for £1,000 outside Staithes Co-op. NYCC Highways expect these High Street bollards to be hit by traffic and they will not replace them indefinitely and could then look at double yellow lines on opposite side of High Street, which could encourage higher traffic speeds. No easy solution - deferred to next meeting to discuss with Cllr David Chance. .

Staithes Bus Shelter roof drains - awaiting repair work to commence. Email from Staithes resident read to meeting requesting new shelters – to refer to Borough Councillors.

Staithes Play Area - Seat base repair - awaiting repair work to commence.

Runswick Lane, H'well: street lights - 4 new ones installed but still problems with two of them.

Missing Headstone - Some progress, but Clerk to seek legal advice on 20th March.

Play Area Repairs - Awaiting cost of repairs from SBC

Tour de Yorkshire - Clerk has spoken with other Clerks and the organisers and there is no free bunting etc. Cllrs voted to purchase posts to enable fencing of wildflower areas to prevent cars parking on newly sown seeds.

Memorial Seat, Staithes - Clerk has had second plaque removed and left note for family.

### **2020:03-05 NY Police Report**

PC Matthew Rogers was in attendance. He reported on 8 crimes in past month and Cllr Fowler reported on recent incident in Staithes Boat Park.

### **2020:03-06 Reports from Borough and County Councillors**

Cllr Chance has sent details of resurfacing of Cliff Road, Staithes followed by installation of double yellow lines in the area.

### **2020:03-07 Planning Matters**

**NYM/2020/0125/FL** - Plum Tree Cottage, Runswick Bay - install rear dormer window - no objection

**NYM/2020/0048/FL** - Pinjarra, Church St, Staithes - Creation of car parking space on adjacent land. - Object on grounds that this is still subject to enforcement order from 1998. Doubt over ownership of the land and unsuitability of area as it is next to the Cleveland Way and will spoil the visual amenity of the area.
