### 2022:01-04 Matters arising from previous minutes

Hinderwell Rockery - fallen wall outside High Farm Hinderwell, since May 2019 - in the hands of the NYCC Highways legal team.

Overgrown trees outside High Farm Hinderwell – NYCC Highways have written to landowner.

Vehicle Activated Sign – to be moved to next location in coming week.

Dog pooh bag dispenser – Dalehouse : Clerk reported that SBC had installed a new litter bin.

Councillors voted to purchase new bag dispenser and purchase a case of 800 bags.

Hinderwell Clock - has been repaired again and is back in place. Scaffolding has now been erected ready for re-pointing work to commence. HPC has secured funding from NYMNPA for the costs. Christmas Lights competition - 2 x Hampers from Old School Tearooms were good value and winners very happy with them. More publicity for next year as Hinderwell's response was down. TV reception - Clerk in constant contact with Arqiva re loss of TV signal – she has manage to get Arqiva's Engineers to return to village and fix many residents TV signals. A final Facebook publicity drive to locate any more residents without TV is planned.

Councillors discussed the two tenders received. Proposed to take the lowest quote – vote taken – favourable by majority.

## 2022:01-11 Play Area Safety Reports.

Clerk had circulated both reports from a safety inspection made in late October 2021 but received in January 2022 Clerk to arrange for all urgent repairs to be carried out ASAP and non urgent ones to get a price.

## 2022:01-12 2022-2023 Budget and Precept

Councillors discussed at length. In view of rising costs it was decided to maintain gross precept at the same level of £19,000 per annum.

### 2022:01-13 Remembrance Services, Hinderwell

Cllr Walker requested that we once more seek a road closure of Runswick Lane on Remembrance Sunday, so that there is room for pedestrians to pay their respects safely. Possibly halt traffic on A174, whilst service is taking place, or place signs asking traffic to slow in respect of the Remembrance Service.

### 2022:01-14 Correspondence

Letter from a member of the public concerned about the planting of daffodils in the roadside verges. Chairman had already replied stating that we had consent from NYCC Highways and financial support from both Scarborough BC and NYMNPA. Public support for the daffodils is good

## 2022:01-15 Parish Maintenance

Staithes: Potholes in top car park have not been repaired despite being reported in August 2021. Cllr Smith believed that income from Car Parks was supposed to be spent on their maintenance – Clerk to ask if this is the case.

Port Mulgrave – water continues to flow down Rosedale Lane and is icy in cold weather Clerk reported vandalism to newly installed kissing gate on Hinderwell Back Lane, NYMNPA have asked that we seek who has done this.
