

# **Minutes of a meeting of Hinderwell Parish Council**

## **5th August 2022, 6.45pm at St Hilda's Old School, Hinderwell**

### **2022:08-00 Those Present**

Cllr I Walker, Chairman. Cllrs: Jackson, Endean, Smith, Brew, Brooker, Bailey and Ellis.  
Five members of the public. Carol Barker, Clerk.

### **2022:08-01 To receive apologies for absence and approve reasons for absence**

Cllrs I and J Longster sent apologies. Proposed to accept by Cllr C Jackson and seconded by Cllr Endean.

### **2022:08-02 Declarations of interest**

### **2022:08-03 Minutes of previous meeting**

Minutes for the July meeting of the Council accepted as a true record. Proposed Cllr Jackson, seconded Cllr Endean.

### **2022:08-04 Matters arising from previous minutes**

NYCC had removed the surplus tarmac at Runswick bank top.

SBC had replied that they would remove debris on Staithes beach

SBC had replied that the toilets at Staithes lower village were in the first phase of refurbishment and it would be a lot later in the year before the outside was re-painted.

Clerk had asked NYMNPAs for signposts to the stepping stones in Staithes but no response yet.

NYCC had replied re large vehicles entering the lower village of Staithes - they are searching for a solution.

Cllr Longster, Clerk and Asst Clerk had attended the official opening of the social housing at Endeavour Close, Staithes.

Still awaiting a reply from Hinderwell Village Hall re the removal of HPC as Holding Trustees.

### **2022:08-08 Planning Matters**

NYM/2022/0490: 19 Porret Lane, H'well: dormer windows front and rear, front door re-located to side.

Removal of shed and erection of car port in front garden: No objections

NYM/2022/0500: 6 Coronation Av, H'well: raise roof height of bungalow and construction of dormer to west:: No objection

NYM/2022/0515: Bank Top Lane, R Bay: Construction of cafe/restaurant/takeaway bldg with car parking. Strongly object as contrary to NYMNPAs own policies and heavy local objections to the proposal.

NYM/2022/0526: Barn Owl Cafe, Seaton Hall Farm, Staithes: change of use to mixed use cafe/holiday let : No objection but advise that work has already been carried out .

NYM/2022/0531: Cliff Farmhouse, Staithes: installation of solar panels on outbuilding roof: no objns

### **2022:08-09 Finance - Authorisation of cheques, New Office computers**

### **2022:08-10 Council meetings at Staithes**

### **2022:08-11 Hinderwell Play Park**

Cllr Walker spoke of his commitment to upgrade the equipment at the Park. HPC to approach SBC to take on ownership and to be in full control of it. Cllr Walker to find out which equipment is used and which is not. HPC to instigate a survey of local children and families as to what is wanted.

### **2022:08-12 Parish Maintenance**

Remembrance Day - Clerk had prices for purchasing the necessary signs. Proposed Cllr Jackson, seconded Cllr Brooker - all in favour.

Parish Benches- Clerk given permission to purchase 2 x recycled benches to replace old ones in Cemetery Proposed Cllr Jackson seconded Cllr Smith. All in favour.

Cllr Ellis wanted the wooden seat at the rear of her home restored. Clerk advised that as it was an old one and no one used it, so this was unlikely. Cllr Smith to inspect the seat.

Cllr Brew asked for area behind Staithes northbound bus shelter to be tidied up. Clerk to send Brian the Caretaker.

Cllr Endean reported an overgrown hedge in Runswick, blocking the pavement

Cllr Ellis reported a missing downpipe on Hinderwell Bus Shelter, Cllr Walker to inspect

Cllr Ellis said that the hedge at Pond Farm was NYCC's responsibility to cut it.

Cllr Walker reported hedge on Hildewell was uncut - Clerk has reported this to Beyond Housing twice

Cllr Brew reported over hanging trees on Dalehouse bank - Clerk has already reported this to NYCC

NYCC letter re Barrass Upper Garden registration as Village Green read to meeting.

Tour of Britain Cycle race to come through Staithes and Hinderwell on Wednesday 7th September.
